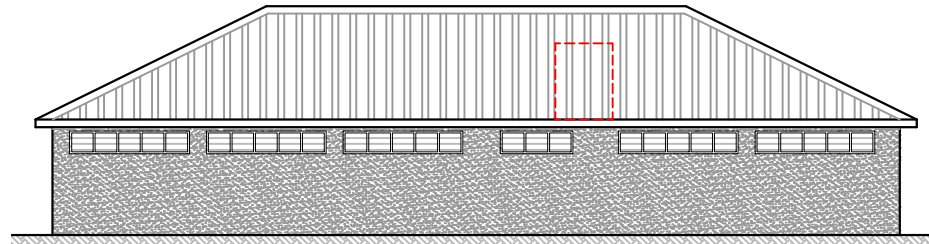

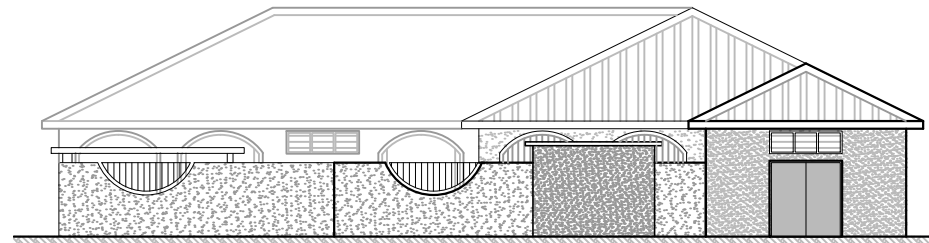
01 Front (north) elevation

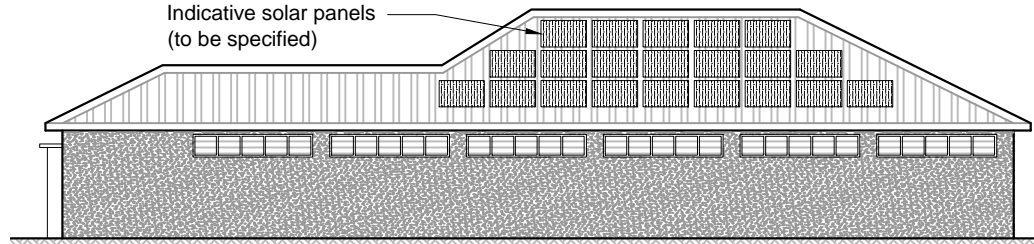


03 Side (west) elevation

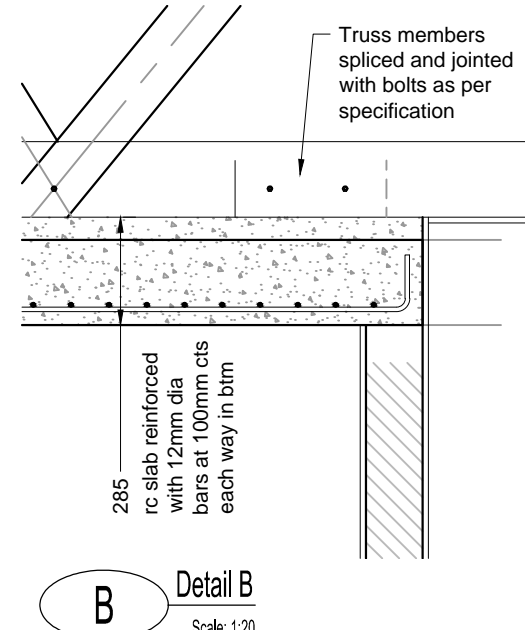

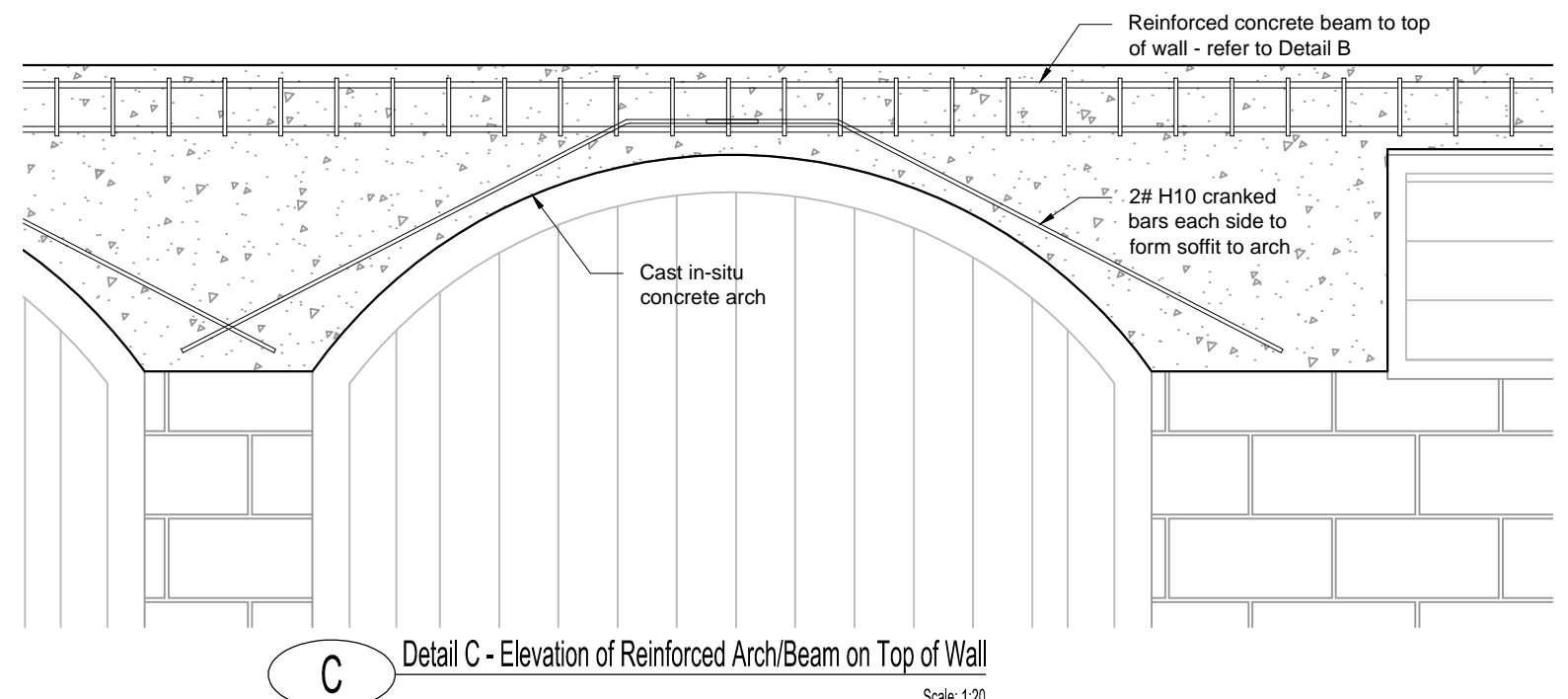
